Students applying to any of HISD's middle school Fine Arts Magnet Programs must audition. To qualify to receive an audition a student must have both of the following:

- A 78 average in core courses for the entire previous year and the first grading cycle of the current year, and
- An S average in conduct for that same period.

Students meeting these criteria will be scheduled for an audition by the school. Students must prepare for the audition according to the published directions.
